

ORDINANCE NO. 977

AN ORDINANCE AMENDING SECTION 18-29 OF ARTICLE II, CHAPTER 18; AMENDING SECTION 18-86 OF ARTICLE III, CHAPTER 18; AMENDING SECTION 18-173 OF ARTICLE V, CHAPTER 18 OF THE CODE OF ORDINANCES, CITY OF PAULS VALLEY PROVIDING FOR INCREASES IN DOMESTIC WATER AND SEWER RATES; AMENDING SECTION 170 OF ARTICLE V, CHAPTER 18 OF THE CODE OF ORDINANCES, CITY OF PAULS VALLEY TO REQUIRE THE BAGGING OR OTHER CONTAINMENT OF WASTE PLACED INTO CITY-PROVIDED CONTAINERS (POLY-CARTS); PROVIDING FOR SUBSEQUENT ADJUSTMENT OF UTILITY RATES BASED ON THE U.S. CONSUMER PRICE INDEX; PROVIDING EFFECTIVE DATES AND TIMES FOR SAID PROVISIONS; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY

AMENDING SECTION 18-170 OF ARTICLE V, CHAPTER 18;

Whereas revenues for the City of Pauls Valley are not sufficient to maintain city operation and additional revenues are necessary:

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PAULS VALLEY:

SECTION 1: AMENDATORY That, effective as of the date and time provided in Section 6 hereof, Section 18-29 of Article II, Chapter 18, of the Code of Ordinances, City of Pauls Valley, Oklahoma, is hereby amended to read as follows:

(a) Rates to be charged for water furnished by the city shall be as follows:

(1) Domestic Rates:

a. First 1,000 gallons	\$18.32
b. In excess of 1000 gallons up to 1999 gallons	\$2.95 per thousand gallons
c. In excess of 2000 gallons at 2999 gallons	\$3.00 per thousand gallons
d. In excess of 3000 gallons up to 3999 gallons	\$3.05 per thousand gallons
e. In excess of 4000 gallons up to 4999 gallons	\$3.10 per thousand gallons
f. In excess of 5000 gallons up to 5999 gallons	\$3.15 per thousand gallons
g. For every thousand gallons thereafter	\$3.20 per thousand gallons

(2) Water furnished outside corporate limits:

a. First 1,000 gallons	\$25.35
b. All gallons in excess of 1,000 and up to 20,000 gallons (per thousand gallons)	\$3.30
c. All gallons in excess of 20,000 gallons (per thousand gallons)	\$3.30

SECTION 2: AMENDATORY That, effective as of the date and time provided in Section 6 hereof, Section 18-86 of Article III, Chapter 18, of the Code of Ordinances, City of Pauls Valley, Oklahoma, is hereby amended to read as follows:

All residential users of the municipally-owned waste water treatment system shall be charged a minimum of Ten and 50/100 Dollars (\$10.50) per month, plus a charge based on metered water consumption as follows:

- a. First 2,000 gallons \$11.45 per thousand gallons
- b. In excess of 2000 gallons up to 2999 gallons \$1.10 per thousand gallons
- c. In excess of 3000 gallons up to 3,999 gallons \$1.10 per thousand gallons
- d. In excess of 4,000 gallons up to 4,999 gallons \$1.10 per thousand gallons
- e. In excess of 5,000 gallons up to 14,999 gallons \$1.10 per thousand gallons
- f. For every 1,000 gallons in excess of 15,000 gallons \$.80 per thousand gallons

All commercial users of the municipally owned wastewater treatment system shall be charged a minimum of Twenty-One Dollars (\$21.00) per month, plus a charge based on metered water consumption as follows:

- a. First 10,000 gallons\$22.90
- b. All gallons in excess of 10,000 and up to 40,000 gallons (per ten thousand gallons).....\$10.95
- c. All gallons in excess of 40,000 (per ten thousand gallons).....\$5.45

SECTION 3: AMENDATORY That, effective as of the date and time provided in Section 6 hereof, Section 18-170 of Article V, Chapter 18, of the Code of Ordinances, City of Pauls Valley, Oklahoma, is hereby amended in part to add a subsection (f) thereto to read as follows:

* * *

(f) All Garbage, Refuse, Rubbish, Waste and/or Yard Waste placed in Waste Containers supplied by the City (as defined in this) shall be bagged or otherwise placed in a container of sufficient strength to contain such Garbage, Refuse, Rubbish, Waste and/or Yard Waste.

SECTION 4: AMENDATORY That, effective as of the date and time provided in Section 6 hereof, Section 18-173 of Article V, Chapter 18, of the Code of Ordinances, City of Pauls Valley, Oklahoma, is hereby amended to read as follows:

(a) The monthly service charge for waste collection using poly-cart containers supplied by City shall be as follows:

<u>Poly-cart Size</u>	<u>Charge</u>
32 gallon	\$10.40

<u>Poly-cart Size</u>	<u>Charge</u>
64 gallon	\$11.45
96 gallon	\$16.65

(b) The monthly service charges for waste collection using dumpsters supplied by City shall be as follows:

<u>Dumpster Size</u>	<u>Collections per Month</u>	<u>Charge</u>
2-yard	1	\$44.05
2-yard	2	\$88.15
2-yard	3	\$132.20
4-yard	1	\$88.15
4-yard	2	\$176.30
4-yard	3	\$264.30
6-yard	1	\$125.10
6-yard	2	\$250.20
6-yard	3	\$375.30
8-yard	1	\$165.65
8-yard	2	\$331.25
8-yard	3	\$496.86

(c) The waste collection service charges for temporary dumpsters shall be as follows:

Setting Fee:	\$28.00
Daily charge while dumpster is in place:	\$1.40
Dumping Fees:	
2-yard:	\$16.40 per dump
4-yard:	\$32.75 per dump
6-yard:	\$50.00 per dump
8-yard:	\$65.50 per dump

(d) The waste collection service charges for temporary roll-off containers shall be as follows:

Setting Fee:	\$190.90
Daily charge while container is in place:	\$1.65
Dumping Fees:	
Municipalities:	\$30.00 per ton
All Other Customers:	\$33.30 per ton
Re-set fee:	\$110.00

(e) The service charges for dumping at the City's transfer station shall be as follows:

Minimum Fee:	\$16.40
<u>Container</u>	<u>Charge</u>
Pick-up (6'-8'):	\$16.40
Trailer (10'-12'):	\$18.55
Trailer (13'-15'):	\$25.10
Trailer (16'):	\$32.75
Trailer (Over 16') and all dump trucks:	\$33.30 per ton

SECTION 5: AMENDATORY That there shall be added to Article V, Chapter 18, of the Code of Ordinances, City of Pauls Valley, Oklahoma, a new Section to be numbered Section 18-88, to read as follows:

Sec. 18-88 Adjustment of Rates to Consumer Price Index

Effective each July 1 for all years subsequent to the passage hereof, all water, sewer and solid waste disposal rates established by Sections 18-29, 18-86 and 18-173 of this Code shall be adjusted up or down based on the United States Consumer Price Index ("CPI") as reported on July 1 of such year (or as soon thereafter as such index can be ascertained) using the CPI for July 1, 2021, as the base index year.

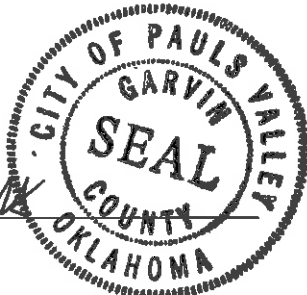
SECTION 6: EFFECTIVE DATE The amendments and provisions adopted herein and set forth in Sections 1-5, inclusive, of this Ordinance shall be effective as of 12:01 a.m., July 1, 2021.

SECTION 7: SEVERABILITY The provisions of this Ordinance are severable, and if any part or provision hereof shall be adjudged invalid by any Court of competent jurisdiction, such adjudication shall not affect or impair any of the remaining parts or provisions hereof.

SECTION 8: EMERGENCY It being immediately necessary for the preservation of the public peace, public health, public safety and morals, an emergency is hereby declared to exist, and the within Ordinance shall become effective immediately upon its passage and approval.

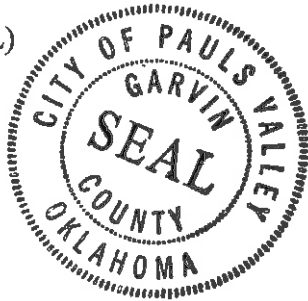
